AN ORDINANCE ALTERING AND ENLARGING THE CORPORATE LIMITS OF THE TOWN OF PIKE ROAD BY INCLUDING WITHIN THE BOUNDARIES OF THE TOWN OF PIKE ROAD THAT TERRITORY OF REAL PROPERTY AS DESCRIBED HEREIN IN THIS ORDINANCE.

WHEREAS, The Town of Pike Road, the owners of all the real property hereinafter described, did file with the Town Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the Town of Pike Road; and

WHEREAS, said petition (attached as exhibit 1) did contain the signatures of all of the owners of the described territory and a map of said property (attached as exhibit A) showing its relationship to the corporate limits of the Town of Pike Road; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the Town of Pike Road and it did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PIKE ROAD, ALABAMA, AS FOLLOWS:

**Section 1.** The Council of the Town of Pike Road, Alabama, finds and declares as the legislative body of the Town of Pike Road that it is in the best interests of the citizens of the Town of Pike Road, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the Town of Pike Road.

**Section 2.** The boundary lines of the Town of Pike Road, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory hereto before encompassed by the corporate limits of the Town of Pike Road, Alabama, and in addition thereto the following described territory, to-wit:

A certain lot of land containing three (3) acres in the S.W. corner of the N.W. ¼ of Section Nineteen (19) Township Sixteen (16) Range Twenty (20), commencing at the corner post on the Range Line, dividing the Lands of Gilder and Kenbler, and the Antioch colored Baptist Church and Mrs. J.E. Williamson, running thence North 313.08 feet, thence East 417.44 feet, thence South 313.08 feet, thence West 417.44 feet to the point of beginning.

Begin at the ¼ Section post on the West Side of Sec. 19, thence North along the Range Line 24 chains, thence South 85, East 11½ chains to the center of Pike Street, thence along said Street 23 chains, thence West 11½ chains to the point of beginning except 3 acres heretofore sold. The amount hereby conveyed is 24 acres more or less, all lying and being situated in the N.W. ¼ of Sec. 19, Township 16, Range 20, Montgomery County, Alabama.

In addition, the police jurisdiction of the Town of Pike Road is hereby extended as provided by law with the addition of the above-described expansion of the corporate limits of the Town of Pike Road and the boundaries of the police jurisdiction shall expand to the distance provided by law to reflect the newly annexed territory.


**Section 3.** This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the petition of the property owners, shall be filed with the Probate Judge of Montgomery County, Alabama.

**Section 4.** The territory described in this ordinance shall become a part of the corporate limits of Town of Pike Road, Alabama, upon publication of this ordinance as set forth in Section 3, above.

## PETITION FOR ANNEXATION

TO: The Mayor and Town Council of the Town of Pike Road, Alabama, a municipal corporation, located in Montgomery County, State of Alabama.

The undersigned Petitioner, pursuant to §11-42-20 through §11-42-24, Code of Alabama 1975, as amended, respectfully petitions the Mayor and Town Council of the Town of Pike Road, Alabama for annexation to the Town of Pike Road of the following described unincorporated territory or property in the County of Montgomery, State of Alabama, to wit:

A certain lot of land containing three (3) acres in the S.W. corner of the N.W.  $\frac{1}{4}$  of Section Nineteen (19) Township Sixteen (16) Range Twenty (20), commencing at the corner post on the Range Line, dividing the Lands of Gilder and Kenbler, and the Antioch colored Baptist Church and Mrs. J.E. Williamson, running thence North 313.08 feet, thence East 417.44 feet, thence South 313.08 feet, thence West 417.44 feet to the point of beginning.

Begin at the  $\frac{1}{4}$  Section post on the West Side of Sec. 19, thence North along the Range Line 24 chains, thence South 85, East  $11\frac{1}{2}$  chains to the center of Pike Street, thence along said Street 23 chains, thence West  $11\frac{1}{2}$  chains to the point of beginning except 3 acres heretofore sold. The amount hereby conveyed is 24 acres more or less, all lying and being situated in the N.W.  $\frac{1}{4}$  of Sec. 19, Township 16, Range 20, Montgomery County, Alabama.

1. That the territory or property described above lies within the police jurisdiction of the Town of Pike Road.
2. That the territory or property described above abuts upon and is contiguous to the corporate limits of the Town of Pike Road.
3. That the undersigned Petitioner is the sole owner of the territory or property described above and requested to be annexed.
4. This Petition is accompanied by a map or plat of the said territory to be annexed, showing with reasonable certainty the territory to be annexed, the boundaries thereof, and its relationship to the established corporate limits of the Town of Pike Road. The map or plat is attached as Exhibit A.

WHEREFORE, Petitioners respectfully request that the territory or property described above be annexed to the Town of Pike Road, Alabama and that the governing body of said Town of Pike Road adopt an ordinance assenting to this annexation and take such action as is appropriate in the premises.

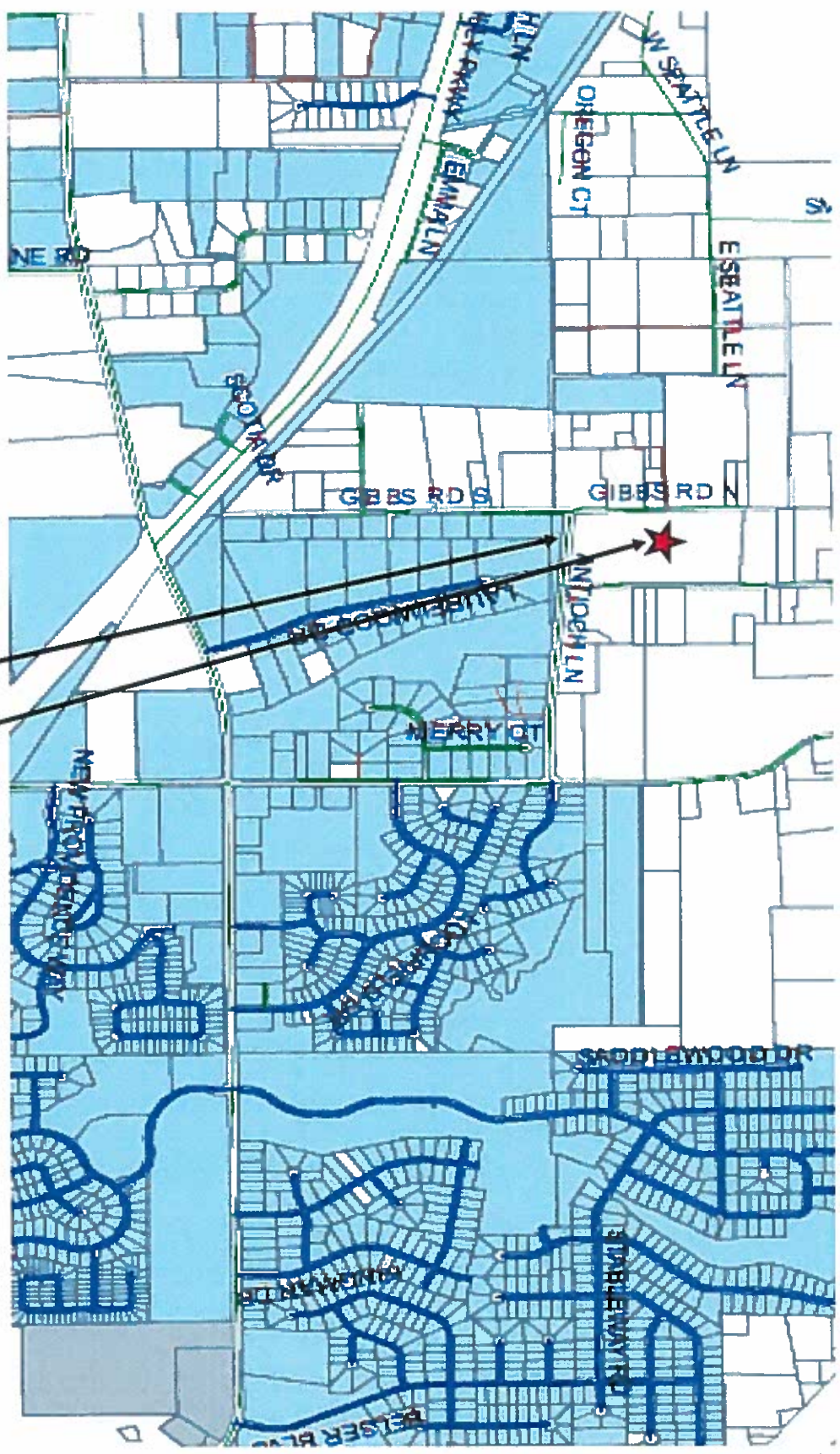
