

Minutes of Pike Road Town Council Regular Meeting
Wednesday, November 26, 2025|7:00 AM
Pike Road Town Hall

Mayor Stone called the meeting to order at 7:02 AM. Councilwoman Bradsher opened the meeting in prayer. Mayor Stone led the Pledge of Allegiance.

Roll Call: Council members present were Angie Bradsher, Marcus Robinson, and Mim Whatley. Doug Fuhrman and Rob Steindorff were absent. A quorum was noted.

Consideration was given to the minutes for the regular council meeting on November 11, 2025, and the November 14, 2025, work session. Councilwoman Bradsher made a motion to accept the minutes as presented. Councilman Robinson seconded. Unanimous consent was given. The minutes were accepted as presented.

Denna Caro with Carr, Riggs & Ingram presented the report for **October 2025** (attached). The October statement shows that our available cash was \$17,344,839. Fund balance is \$17,776,699 which is \$1,061,225 more than last year. Our revenues YTD are \$1,072,855, which is \$422,988 more than the prior year. Our net income was \$616,361 at the month end. The ratio of income to expenses is 57%. The months of operating expenses on hand are 28 months. Caro also reviewed several revenue categories.

Councilwoman Whatley made a motion to accept the financial statements for October 2025 as presented. Councilman Robinson seconded. A unanimous vote was given. The financial statements were approved as presented.

Old Business

The only item of old business was **Ordinance 2025-0607 TPR-Access Management Policy**. After much discussion, Councilwoman Bradsher made a motion to approve **Ordinance 2025-0607 TPR-Access Management Policy**. Councilwoman Whatley seconded. The vote was unanimous. The ordinance was adopted. (**Ordinance 2025-0607**)

New Business

The first item of new business was **Ordinance 2025-_____ Annexation of 603 Penn Ave**. The owner was present to answer any questions of the council. This was considered the first reading of the ordinance, and it will be on the agenda at the next regularly scheduled meeting.

The last item of new business was **Resolution 007-2025/2026 Re-schedule Regular Council Meeting Date** from December 24, 2025, which is a holiday and move to December 17, 2025. Councilwoman Bradsher made a motion to approve **Resolution 007-2025/2026 Re-schedule Regular Council Meeting Date**. Councilman Robinson seconded. Unanimous consent was given. The resolution was approved. (**Resolution 007-2025/2026**)

Other Business

Councilwoman Bradsher had inquiries about the roundabout on ALDOT public meeting on the roundabout at Meriwether Road/Wallahatchie Road/Pike Road, the roundabout on Wallahatchie Road and the VFD's board members and other information. There was much discussion on all three topics.

With no further business at hand, Councilwoman Bradsher made a motion to adjourn at 7:53 AM. Councilman Robinson seconded the motion. Unanimous consent was given. The meeting was adjourned.
