

Minutes of Pike Road Town Council Regular Meeting
Wednesday, December 17, 2025|7:00 AM
Pike Road Town Hall

Mayor Stone called the meeting to order at 7:05 AM. Councilman Steindorff opened the meeting in prayer. Mayor Stone led the Pledge of Allegiance.

Roll Call: Council members present were Angie Bradsher, Marcus Robinson, Rob Steindorff, and Mim Whatley. Doug Fuhrman arrived at 7:07 AM. A quorum was noted.

Consideration was given to the minutes for the regular council meeting on December 8, 2025. Councilman Fuhrman made a motion to accept the minutes as presented. Councilman Robinson seconded. Unanimous consent was given. The minutes were accepted as presented.

Denna Caro with Carr, Riggs & Ingram was not in attendance to present the report for **November 2025** (attached). It will be presented with the December 2025 report in January 2026.

Old Business

The only item of old business was **Ordinance 2025-0609 Re-Zoning of Lot 5 Elwood Drive**. Councilwoman Bradsher made a motion to approve **Ordinance 2025-0609 Re-Zoning of Lot 5 Elwood Drive**. Councilwoman Whatley seconded. The vote was unanimous. The ordinance was adopted. (**Ordinance 2025-0609**)

New Business

The only item of new business was **Resolution 008-2025 School Board Appointment, Place Five**. There was minimal discussion before a vote was cast by the council. Once Mark Williams, Councilman Steindorff and Town Clerk, Lisa Burke counted votes, it was announced that the applicant with the majority votes was Mona Hurston. Councilman Fuhrman made a motion to approve **Resolution 008-2025 School Board Appointment, Place Five** naming Mona Hurston as the appointment for the remaining term of Place Five. Councilwoman Bradsher seconded. The vote was unanimous. The resolution was approved. (**Resolution 008-2025**)

Other Business

Councilwoman Bradsher requested an update on the VFD's board members. Mark Williams noted that he would be reaching out to find out who the current board members are for each VFD. Mayor Stone also noted that thanks to Councilwoman Bradsher, he was involved and working with the County on the one cent sales tax that has been dedicated to education in the county. Stone noted that they hope to have a remedy to cover any shortage that may fall upon the school if the tax is reduced moving forward.


